Payment for classes are due on the 1st of each month. A \$10.00 late fee may be assessed to accounts not paid by the 10th.

Payments can be made by cash, check or automatically withdrawn from your checking or savings account. If you sign-up for automatic withdraw, your account will be debited the 10th of each month. To sign-up for automatic payments, please fill out an ACH form in the office.

Registration fee is \$25.00. Each additional child per immediate family is \$15.00.

Students are allowed to sign-up for classes on a monthly basis. If your child is enrolled in a class and you wish to discontinue the program, please fill out a "discontinuance" form at the front desk 2 weeks prior to the end of the month. If you do not notify us, you will be charged for the following month of classes. This gives us time to allow other students to join the class.

Parents are welcome to watch classes from the upstairs viewing area, however we ask that you do not disrupt the class by instructing or talking to your child during class time.

Class fees and registration fees are non-refundable. We do not allow missed classes to be made-up or deducted.

Our fee structure is based on the number of hours per week your child takes lessons.
